



Chiang Mai Rajabhat University Announcement

on

Measures for Prevention of the Spread of Coronavirus Disease 2019 (COVID-19) (No.9)

With reference to the announcement of Chiang Mai Rajabhat University on Measures for Prevention of the Spread of Coronavirus Disease 2019 (COVID-19) (No.8), dated on 29th July 2021, which was effective from 1st August 2021 to 31st August 2021, together with the Order of Chiang Mai Communicable Disease Committee No.137/2564 on Measures for using buildings or places for conducting teaching, dated on 31st August 2021, the Order of Chiang Mai Communicable Disease Committee No.93/2564, date on 28th July 2021, and the Order of Chiang Mai Communicable Disease Committee No.72/2564, dated on 11st July 2021, which order all schools and institutions to refrain from using school/institution buildings or places for conducting teaching in the regular form (on-site), consider to conduct teaching in other forms that refrain from assigning assignment in the form of gathering, and require all university administrators consider to use the measure of working from home for reducing staff's commute to work due to the wide spread of Coronavirus Disease 2019 (COVID-19) consecutively.

Therefore, for monitoring, preventing, and reducing the risk of Coronavirus Disease 2019 (COVID-19) infection in Chiang Mai Rajabhat University and for the safety of faculty members, staff, and students of Chiang Mai Rajabhat University, Chiang Mai Rajabhat University hereby announces the guidelines to practice as follows:

1. Do not use any buildings or places located in Chiang Mai for conducting teaching, examination, and training or doing any activities.

2. Faculty members and staff are required to work from home. Deans, Directors, and Division Directors or equivalent are required to plan and monitor work assignment of staff as appropriate as follows:

2.1 To modify work schedules or adjust work overlapping schedules of staff as appropriate and/or

2.2 To assign staff to work from home, not the workplace, and set work goals as well as set the form of work communication, coordination, and work reports or work progress to the head sectors as appropriate. The staff should not be or present at any inappropriate places during working hours.

In case of works related with students, staff, and general public services, the head sectors are required to follow the above guideline No.2 to assign work assignments effectively and properly to prevent any work damages/problems.

In case of emergency, the head sectors shall request staff to return to the workplace.

3. To conduct teaching for students, regular program students, special program students, and graduate students are required to follow the Chiang Mai Rajabhat University Announcement on Guidelines for Conducting Teaching in the 1st Semester of Academic Year 2021 during Coronavirus Disease (COVID-19) Outbreak Situation, announced on 31st May 2021 and the announcement (No.2), announced on 19th July 2021.

4. Any activities or other gathering with many people that have close contact and risk of transmission in COVID-19 are required to follow the Order of Chiang Mai Communicable Disease Committee. In case of necessity, it is required to propose to the university for consideration in asking for permission from the Chiang Mai Communicable Disease Committee and to follow the measures for prevention of the spread of Coronavirus Disease (COVID-19) of Center for COVID-19 Situation Administration (CCSA) strictly. In case that it is necessary to organize the activities, they shall be operated in the form of online activities.

5. Faculty members and staff are required to follow the measures for prevention of the spread of Coronavirus Disease (COVID-19) by wearing fabric face mask/medical face mask and maintain social distancing strictly in all activities. In case of having been in the high risk areas/business places/activities, it is required to follow the measures of self-quarantine strictly.

6. The administrators of Chiang Mai Rajabhat University are required to prepare and closely monitor the situation continually. If having any related problems/issues, the report should be immediately reported to the President.

7. In cases where there is a problem of following this announcement, the President shall have the final decision.

Please kindly be informed and strictly follow accordingly.

This announcement takes an effect from 1st September 2021 to 14th September 2021 or further notice.
