



Chiang Mai Rajabhat University Announcement
on
Guidelines for Conducting Teaching in the 1st Semester of Academic Year 2021
during Coronavirus Disease (COVID-19) Outbreak Situation (No.2)

Pursuant to the announcement of Chiang Mai Rajabhat University on the Guidelines for Conducting Teaching in the 1st Semester of Academic Year 2021 during Coronavirus Disease (COVID-19) Outbreak Situation, dated on 31st May 2021, and due to the outbreak of Coronavirus Disease (COVID-19) situation, that viruses constantly mutate into new variants leading to public health crisis, together with the announcement of the Center for COVID-19 Situation Administration No.10/2021, dated on 17th July 2021 on the designation of maximum and restricted controlled areas, highly controlled areas, controlled areas, and under high surveillance areas with the lists of provinces in each area to enforce the measures, Chiang Mai Province was designated as the highly controlled areas. Therefore, in order to conduct teaching in the 1st semester of academic year 2021 effectively and to reduce the risk of the spread of Coronavirus Disease (COVID-19), the university administrative committee, meeting on 16th May 2021, agrees to announce the Guidelines for Conducting Teaching in the 1st Semester during Coronavirus Disease (COVID-19) Outbreak Situation (No.2) as follows:

1. For teaching for regular program students, special program students, and graduate students in the 1st semester of academic year 2021, and International College students in the summer semester of academic year 2020 and the 1st semester of academic year 2021, lecturers are required to conduct teaching in the form of online in all courses throughout the semester by covering contents, competencies, and learning outcomes of each course.

2. For mid-term and final examination in the 1st semester of academic year 2021, and the final examination in summer semester of academic year 2020, and the mid-term examination in the 1st semester of academic year 2021 of International College, lecturers are required to modify the form of examination in other forms, which can assess the appropriate learning outcomes of each course by do not administer the examination in classroom.

3. For the internship/cooperative education training courses of students, faculties/colleges are required to consult with the entrepreneurs for considering the appropriate forms of internship/cooperative education training courses by following the measures to prevent the spread of Coronavirus Disease (COVID-19) or adjusting other appropriate forms of internship/cooperative education training courses by considering the purposes and learning outcomes of courses.

4. For the comprehensive examination/qualifying examination or concept paper/thesis/independent study defense examination in graduate programs, online platform or integrated online meeting system can be practiced.

This announcement was made for conducting teaching and examination of Chiang Mai Rajabhat University educational administration in Chiang Mai Province area.
