



Chiang Mai Rajabhat University Announcement on Guidelines for On-Site Teaching and Learning

In order to conduct effective teaching and learning of Chiang Mai Rajabhat University under the measures for prevention and control of the spread of Coronavirus Disease (COVID-19) according to the order of government, together with the Regulation Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548, the Urgent Letter from Office of the Ministry of Higher Education, Science, Research and Innovation No. ๐๖ 0200.6/๖15982, dated on 28th October 2021, and the Order of Chiang Mai Communicable Disease Committee No. 300/2564, dated on 3rd December 2021 on the Measures for Using Buildings or Places for Conducting Teaching and Learning.

Therefore, in order to conduct teaching and learning in the 2nd semester of Academic Year 2021 effectively and to reduce the risk of the spread of Coronavirus Disease (COVID-19), the university committee meeting no.16/2564, dated on 22nd December 2021 agrees to announce the guidelines for on-site teaching and learning as follows:

1. To conduct on-site teaching and learning from 10th January 2022 onwards in all courses except courses in General Education required to conduct in the form of online.

2. Lecturers and students in on-site classes are required to follow the measures for prevention and control of the spread of Coronavirus Disease (COVID-19), the details are as the Chiang Mai Rajabhat Announcement on Measures for Prevention of the Spread of Coronavirus Disease 2019 (COVID-19).

3. To conduct teaching and learning in lecture courses, lecturers conduct teaching in the classroom which is designated in the class schedule and limit the number of students in the classroom according to the university specification.

- 3.1 For lecture courses, lecturers conduct on-site teaching in the classroom which is designated in the class schedule and the number of students cannot exceed the seats specified by university. If the total number of enrolled students exceeds, lecturers conduct a concurrent classroom (both on-site and on-line at the same time.)

3.2 For laboratory courses, practical teaching using specialized tools, lecturers conduct teaching in the classroom which is designated in the class schedule, each section cannot exceed 30 students and must follow the procedures for using the laboratory strictly. If there are more than 30 students, lecturers are required to assign small groups to reduce the number of students as appropriate.

4. The final examination is administered on-site except courses in General Education, all courses are administered online.

5. For the internship/cooperative education training courses of students, faculties/colleges are required to consult with the entrepreneurs for considering the appropriate forms of internship/cooperative education training courses or adjusting other appropriate forms of internship/cooperative education training courses by considering the purposes and learning outcomes of courses.

6. For the comprehensive examination/qualifying examination or concept paper/thesis/independent study defense examination in graduate programs, online platform can be practiced.

7. The President shall be in charge of the compliance with this announcement with the authority of interpreting and ordering. In cases where there is an issue, the final decision shall be made by the President.
